

## **CAMPING REGULATIONS**

**As a result of the Regional Ordinance No.547 of 17/05/2020**

### **“Exhibit2 - Regional Guidelines”**

Dear Guest

In order to ensure your stay in total happiness and safeness, we want to inform you of the measures we have adopted within our organization.

Our staff, in the last weeks, have been working hard to respect the Regional Ordinance N°547 of the 17/05/2020, and draft a regulation that can be respectful towards the health of our customers as well as our staff.

From it follows :

#### **1 - CHECK IN:**

During the access to the administrative offices, it is recommended to respect the vertical and horizontal signs that will be found within.

During the check-in phase it will be requested to compile a “Self certification” for each guest and member of the family, on it will be the seguent points will be mentioned :

- To have a body temperature inferior of 37.5° degrees celsius and that no influential symptoms from respiratory infection (fever, cough, cold, conjunctivitis) are present ;
- Not to be subjected from quarantine measures, that is, not to be resulting positive to the COVID-19 virus and haven't had any contact in the last 14 days with anyone that have contracted the virus ;
- To be in consciousness from the measures of containment of the contagion existing from the date of concerning restrictions on the possibility of moving individuals across the country ;
- To be in consciousness from the sanctions expected from the art.4 of the decree law of 25 of march 2020, n. 19 in case of false declarations ;
- To report every any deterioration in the personal health and the upcoming of symptoms / Flu from the aforementioned COVID-19 ;
- To accept and put in act everything that is expected from the present regulation ;

It should be noted that parents are responsible for their children’s actions and special cooperation is therefore required.

In any case, check-in operations are encouraged remotely, online or via the app.

## **2 - CAMPING PITCHES:**

The pitches are delimited specifically, it is required therefore the respect of the areas of own expertise as a way that the spontaneous movement of the mobile vehicle could violate existing rules ( Ord. Reg.LombardiaN-547 All. II Camping Pitches ).

It is recommended the cleaning and sanitation of all the interior and exterior furnishings of own property.

## **3 – BUNGALOW/APARTMENTS/TENDS:**

No particular rules are required to apply for guests, from the ones already listed, it is forbidden to assemble with people from different households, it is obligatory to use the facemask whenever the guest is moving to different common camping spaces.

## **4 – COMMON BATHROOMS:**

Even in this case it will be guaranteed the interpersonal distances to one meter of the common sinks and at the external washbasers used for sanitizing the dishes.

Signs have been displayed by the bathroom block, in order to invite you to use in the proper manner, the use of hydro-alcohol solutions and to avoid the assembly of people in the peak hours, it is recommended to respect the rules indicated.

## **5 – SAND BEACH:**

The area will be dotated of specific informational signs which are recommended to respect. There will be hygiene products available to use for all of our customers.

The guests can take their own deck chairs as long as the minimum distance of two meters, from one deck chair to the other, is respected.

The individual sports that occur on the beach or in the water (rackets, swimming, surfing, windsurfing ) can be practised just as usual, in the respect of the measurements of interpersonal distancing. Other team sports are prohibited.

## **6 - COMMON AREAS OF RECREATION :**

It is reported that the following common areas won't be open to operate : multifunctional field, playground. The tennis court will be available only via prenotation. The swimming pools will have a regulation sign by the entrance.

## **7 – SANITATION ACTIVITIES:**

Crucial point of importance in order to avoid the spreading of the Virus.

It is recommended that every guest respects personal hygiene in every part of the structure.

It will be our concern to intensify for the whole season the activities in regards to the sanitation of our camping, taking every necessary step to prevent the spread of the Covid-19, in particular:

- ✓ For the bathrooms and all the common areas we have introduced cleaning interventions for at least 3 times a day: in the morning, in the afternoon and in the evening ;
- ✓ A regular cleaning and disinfection of the closed local and the adjacent areas will be made, guaranteeing an adequate air recycling.
- ✓ Within the Bungalow, the apartments and the tents, there will be a complete sanitation in the phase guest turn change, with the particular attention towards the air filters ;

We remind as well some simple rules to apply during the stay:

- It is obligatory to use face mask in the common areas ;
- It is recommended to respect the signs that our guests will find within our camping
- It is obligatory to apply the social distancing of at least 1 m - 1.5 m in between people from different households.

- It is forbidden for gatherings in between people from different households.

Keep in mind that your own actions will influence other security.

The violations of the present regulation may be a reason of exclusion to the subject person from the writing camping.
